

## Nifty Rollover Analysis


- The rollover for Nifty Futures advances as 48% positions got rolled over to the July series as on D-2 days prior to expiry.

- 5. The Market wide June expiry rollover is at **58%** on **D-2** as compared to **57%** on same day of previous expiry.


## **Banknifty Rollover Analysis**


