- 5. The Market wide March expiry rollover is at **59%** on **D-2** as compared to **58%** on same day of previous expiry.


## **Banknifty Rollover Analysis**


- The BankNifty March expiry rollover is higher at 76% on D-2 compared with 47% on same day of previous expiry.


